VOORWAARDEN

Article 1 Agreement

1.1 - There is an agreement upon submission of the registration form with signature.

1.2 - Registrations are processed in order of receipt.

Article 2 Payment

2.1 - In the event of payment in installments, payment must be made in full, even if one stops in the interim.

2.2 - By completing this registration form, the participant enters into an obligation to pay, unless one cancels according to the conditions below.

Article 3 Cancellation

3.1 - The participant may cancel the registration, however this may incur costs;

3.2 - Cancellation within 7 days after the registration date is free of charge, except if the cancellation takes place less than 7 days before the start of the training or after the start of the training.

3.3 - For cancellations later than 7 days after the registration date and up to two months before the start of training

a maximum of 80% will be refunded.

3.4 - In case of cancellation later than 7 days after the registration date and up to one month before the start of the training, a maximum of 50% of the full training fee is refunded.

3.5 - Cancellation later than 7 days after the registration date and less than one week before the start of the course does not entitle to a refund.

3.6 - After the start of the training course, refunds are NOT possible under any circumstances, even if this would fall within the aforementioned cancellation period.

Article 4 Changes in training

4.1 - 5 Elements Yoga Academy/Yogapoint Arnhem has the right to change the training days, times and content.

4.2 - 5 Elements Yoga Academy/ Yogapoint Arnhem has the right to cancel the training or refuse participation of the participant. The amount paid will be refunded in this case. After attending classes, a proportional part will be refunded in this case.

Article 5 Liability

5.1 - Elements Yoga Academy/ Yogapoint Arnhem cannot be held liable for any damage whatsoever.

5.2 - Participation is entirely at your own risk.

Article 6 Other conditions

6.1 - A diploma will ONLY be issued if the participant has met the requirements of 5 Elements Yoga Academy/ Yogapoint Arnhem. This means that each part must be completed with a pass and that participants must have attended at least 85% of the lessons.
